The legal basis for this is Art. 6 Para. b) GDPR. Bank details are processed for contribution management purposes. The legal basis for this is Art. 6 Para. b) GDPR.

## 4. Justified interests of the association

The "Friends of WMIS e.V." has a legitimate interest in collecting personal data of the members for the purpose of fulfilling the membership duties / rights from the statutes and the association regulations.

## 5. Recipient of personal data

## 7. Retention period

The legal retention period is 10 years.

## 8. Rights of the persons concerned
