Who are we?

The Friends of WMIS e.V. is an independent, state-registered volunteer organisation by parents, WMIS staff, and community members. It was created in 2018 to foster educational, interpersonal and infrastructural development at WMIS. Our activities are funded entirely by membership fees, individual and corporate donations and fund-raising events held throughout the school year. Parent support is vital; each contribution, in cash or in kind, furthers our ability to provide a welcoming learning environment in which our children can thrive and live up to our school motto 'Earth – Arts – Action'.

Why join?

As a state school, funding at WMIS for curriculum-related and material improvements is sometimes limited. Funding, however, is needed to ensure the quality of bilingual education and provide the many opportunities to the benefit of our children. You will be joining a growing community. Already more than half of all WMIS families contribute to the Friends, raising over 25,000 EUR for essential projects annually. Recent highlights, activities & purchases include the following:

- Run2Read fundraiser for library infrastructure and books (7.500 EUR)
- Acquisition of a Grant from Bayer Science Foundation for "Discovering the Senses" project (1.100 EUR)
- Acquisition of Community Development Grants for the school garden (2.900 EUR)
- Funding of GEV and class email distribution lists (140 EUR p.a.)
- Purchase of a stage, shadow theatre, music room acoustics (6.500 EUR)
- Set-up and management of WMIS Online Shop, Production of yearbooks and event management in cooperation with GEV
- Acting as trustee for the school's education budget that has funded all consumables, classroom projects and equipment for the past two schoolyears (totalling 21.000 EUR)

Glimpse into the new school year:

We are looking ahead to financing a set of tablet computers for weekly digital lessons for all classes (6.000 EUR) plus we are proud to make a new cooperation with "Tanz ist Klasse" from the State Ballet Company/ Staatsballett Berlin possible (3.000 EUR).
